The statement is about the traineeship wich will take place

This statement is fully known and understood by the apprentice and the training courses master who agree this statement by signing the document.

art.2.- The training courses master will let the student take part into the professional activities related to his work, so that the student can become familiar with the life surrounding this particular working field and develop human contact qualities, his own decision spirit, and his sense of organisation during the 22 EFFECTIVE minimum working days. If possible, the training courses program will be established in coloboration with the training courses directors.

art.3.- The training courses master will give his appreciation (feelings) about the work done by the apprentice and his behaviour to the Faculty.

art.4.- If a big miss of discipline occurs (bad behaviour) , the training courses master can stop the training courses after warning the training courses directors.
Also, if the training courses master has not a professional behaviour , then the training courses directors can stop the training courses after warning the training master.

art.5.- The apprentice will actively participate into the enterprise life and will follow its discipline, especially concerning the timetables, the rhythm and the nature of the works, the safety and hygiene of these works.

He will also follow the rules of discretionary if applied to his work.

art.6.- The apprentice will hold a DAILY activities calendar during his training courses and will make it signed by the training course master at the end of every week .

art.7.- If the training course master wants to read the courses report to approve it, then the apprentice must respect the delays set by the training courses master.

art.8.- The apprentice will write a confidential report about the training courses, he will give it to the training courses directors and give a copy to the training courses master. The mark given to the report counts for the 3rd year in bachelor engineering.

art.9.- The training courses director guarantees that the apprentice is affiliated to an insurances for health cares.

art.10.- During his training courses the apprentice remains a student at Catholic University of Louvain which owns insurances contracts for

- Civil responsibilities: S.A. AG 1824 registered with the number 6.300.600
- body injuries: same company as before, registered with the number 7.302.765

This insurance covers financial consequences of casualties caused by the apprentice (related to the articles 1382 and 1386 of the Belgian Civil Code.)

The same insurance company covers the student for body injuries encountered during the training courses, including during the travel from and to ,the student's home to the training courses place .
